They moved in a 2022 travel trailer to the side of her parents' home. Ella reports that they received a letter about their trailer from the town and is now looking to receive a conditional use permit in order to keep the trailer there and live in it. Mayor Johnson is concerned about how long they will be there. They have no idea. Sewer is not hooked up. There is rock work. Vice Mayor Scott made a motion to approve the conditional use permit. Councilor Ballard requested that the motion be amended to up to one year. Vice Mayor Scott revised the motion. He then made the motion to approve the conditional use permit for one year at that time they will have to come in and request another one. Councilor Ballard seconded the motion, with all in favor.

Patsy reported that she is in need of care. Tony dose all of the driving, All the lifting and all the reading of her legal documents, she can't see very well. He also helps with all of the work. She reported that he lives in a travel trailer to the side of her house. Vice Mayor Scott made a motion to approve the conditional use permit for one year. Councilor Banks seconded it and all in favor.
